I was also certified on e-Ticket where I was able to issue citations on traffic stops that were conducted on the road under the Chief's supervision. I reported to the station every Monday, Wednesday and Friday starting promptly at 0600-1200 hrs. My duties consisted of revamping the standard procedures and policies for the department, "call of the calendar". I was also on the road where I would shadow the Chief on domestic calls, traffic stops, and maintenance orders. During my internship I was also brought along to Justice of the Peace court and Court of Common Pleas in Dover and was able to sit in on some cases. After I received my mandatory 60 course required hours from the department, I didn't want to just stop coming. I continued going to the department every Monday.
